Its high solids content minimizes the shrinkage typically seen in coatings with high amounts of solvents, ensuring better overall coverage. NP866T Clear has excellent water resistance, high abrasion resistance, and premium color retentive properties. NP866T Clear contains less than 250 g/l VOC.

PRODUCT DESCRIPTION: Basic Uses: NP866T Clear is an abrasion resistance and weather resistant topcoat used in decorative broadcast or chipped traffic bearing coating systems. Please refer to the pertinent Application-Specification Guide on each of these systems. NP866T Clear is used where optimum weather resistance, abrasion resistance and color stability are required. It is used in conjunction with Non-Gassing NP863B and NP865IT base membranes, intermediate membranes and NP866T colored topcoat. The cured Clear topcoat easily withstands the extreme environmental conditions encountered in exterior construction environments. When used in conjunction with elastomeric base membranes, the NP866T Clear composite system contracts with lower temperatures and readily expands when temperatures increase. NP866T Clear may also be used alone as an abrasion-resisting maintenance coating

<u>LIMITATIONS</u>: Containers that have been opened must be used within one or two days since the product is a moisture-reactive material that will gel or set up when exposed to moisture in the air. Keep lid tightly sealed when material is not in use. Tire contact and chemical exposures may cause staining.

SHELF LIFE: Twelve (12) months after manufacture when continuously stored indoors in unopened metal pails at temperatures under 80°F. Stir thoroughly prior to use.

<u>INSTALLATION:</u> Surface Preparation: All surfaces to be coated with NP866T Clear must be thoroughly dry and free of all contaminants, including oxidation on old topcoats or base coats as well as construction debris or deposits. As a moisture cure product, the relative humidity should be greater than 30% and less than 90% during the application and cure of the product.

APPLICATION: NP866T Clear is normally applied at a rate of 80-100 square feet per gallon, per coat, resulting in a film thickness of 16 to 20 wet mils. Coverage will vary depending on the aggregate size, texture or degree of surface porosity. The larger the aggregate used, the lower the coverage due to the greater surface area being covered. NP866T Clear is easily applied by squeegee, roller, or notched trowel. Always follow by back rolling. At 50% relative humidity and 77°F, the coating will be dry to the touch within 16 hours. Traffic should not be allowed on the finished coating for 24 hours. NP861A accelerator may be added to NP866T Clear to allow for light traffic on decks within a matter of hours. Please refer to the Technical Bulletins on accelerators or contact NPI.

PRECAUTIONS: Before using this product, read the container precautionary label and the SDS data sheet carefully. Exposure to urethanes or petroleum solvents may cause allergic skin or respiratory reaction. Do not get into eyes, onto skin, or clothing. If contact occurs, flush affected areas with soap and water. Moisture trapped under the cured NP866T Clear has the potential to create a fog or cloudy layer under the clear coating.
